Personal data that we process

Thomas Boers B.V. Process your personal data by using our services and / or by providing it to us yourself.

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. For what purpose and on what basis we process personal data

Thomas Boers B.V. processes your personal data for the following purposes:

- Handling your payment
- You can call or e-mail if necessary to carry out our services
- inform you about changes to our services and products
- To deliver goods and services to you

- Thomas Boers B.V. also processes personal data if we are legally obliged to do so, such as information we need for our tax return.

Automated decision-making

Thomas Boers B.V. does not take decisions based on automated processing on matters that can have (significant) consequences for people. This concerns decisions taken by computer programs or systems, without involving a person (for example, a Thomas Boers B.V. employee). Thomas Boers B.V. uses the following computer programs or systems:

How long we store personal data

Thomas Boers B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use a storage period of seven years.

Sharing personal data with third parties

Thomas Boers B.V. does not sell your information to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Thomas Boers B.V. remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Thomas Boers B.V. uses only technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Thomas Boers B.V. and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to info@thomasboers.nl.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at

the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.
